East African Crude Oil Pipeline (EACOP) LTD. (Company) Tanzania invites experienced and reputable organizations to express their interest in provision of fire suppression unit for company server, firefighting equipment, installation, operation and maintenance services to the East African Crude Oil Pipeline project.

The EACOP project involves the construction and operation of a buried, cross-border pipeline to transport crude oil from the Lake Albert area in Uganda to the eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale in Hoima District, Uganda to Chongoleani, Tanga Region, in Tanzania. The length of the pipeline is 1,443 km, of which 1,147 km will be in Tanzania.

EACOP intends to enter a contract with a reputable vendor for providing fire suppression systems and firefighting equipment supply for its Headquarters in Dar es salaam.

BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES:

- Supply of a current model Fire Suppression system suitable for a modern ICT Server.
- Supply and maintenance of the suppression system and firefighting equipment.
- Provision of qualified manpower to carry out periodic maintenance of firefighting systems installed.
- Compliant to environmental protection.
- Compliant to Firefighting protection and certified.
- Compliant to TBS standards for fire and firefighting equipment.
- The brief scope of work under this contract shall be as follows: Providing firefighting system operation and maintenance services including manpower.

MINIMUM REQUIREMENTS:

Companies or organizations expressing their interest are required to submit documentation of their:

- Letter of interest clearly indicating the Tender Reference Number.
- Detailed Company Information with Organization structure, List of manpower with CVs of key contact personnel.
- Proof of registration as Firefighting dealer as required under Tanzanian Law.
- Proof of Business License, registration with the Tanzania Revenue Authority (TRA) and Tax Clearance Certificate for the latest year available.
- Energy Regulatory Commission practicing license.
- Brief description of experience in similar services.
- Statement of experience with at least three (3) similar undertakings.
- Financial capacity to deliver the services required including submission of financial accounts for the year.
- Registered with the EVVURA Local Supplier Service Provider (LSSP) database at the time of submission of the response to this expression of interest is strongly recommended.
- Compliance with Local Content Regulations, 2017 and Local Company definition.
- Evidence of organization HSE Management Systems & policy, procedure, and process in compliance with applicable Local and Industry standards for similar works.
- Certificate of Incorporation (attach copy).
- Quality assurance & Quality control plan/ procedures in place for the execution of similar type of work, Copy of ISO or any other certification as applicable.
