

## REQUEST FOR EXPRESSION OF INTEREST (EOI) FOR RAP IMPLEMENTATION VALUATION SERVICES FOR THE EACOP PROJECT IN UGANDA - REFERENCE: 10006598

TOTAL East Africa Midstream B.V. (Company) Uganda, an Oil and Gas company, requires the services of an experienced and reputable company(s) to provide valuation services during implementation of the Resettlement Action Plan (RAP) for the East African Crude Oil Pipeline (EACOP) Project.

The EACOP Project involves the construction and operation of a buried, cross-border pipeline to transport crude oil from the Lake Albert area in Uganda to the eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale in Hoima District, Uganda, to Chongoleani, Tanga Region, in Tanzania. The length of the pipeline is 1,443 kilometers [km], of which 296 km will be in Uganda.

The section of the pipeline in Uganda will traverse ten (10) Districts, comprising Hoima, Kikuube, Kakumiro, Kyankwanzi, Mubende, Gomba, Sembabule, Lwengo, Rakai and Kyotera.

## BRIEF DESCRIPTION OF THE SCOPE OF WORK:

The EACOP Project has prepared a Resettlement Action Plan (RAP) which describes the process of land access, compensation, relocation support and livelihood restoration for affected persons along the pipeline route.

COMPANY requires the services of an expert resettlement valuation company with significant experience of large scale RAP implementation in Uganda, in compliance with national law and international funder standards. Services to be provided include: Disclosure of compensation packages to Project Affected Persons (PAP), Compensation Agreement signing, boundary rectification, Land Title transfer, issuance of Notices to Vacate, installation of boundary pillars, and land and asset valuation services.

The scope will require the company(s) to engage with affected households along the route of the pipeline, as well as Government

bodies involved in land acquisition and Land Title transfer at the local, District and National levels in Uganda.

## MINIMUM REQUIREMENTS:

Companies expressing their interest are required to document their request with:

- Experience/performance in delivering tasks outlined above on similar large-scale projects in Uganda, in compliance with notional and international standards
- Key suitably qualified, experienced and registered / accredited lead personnel (in fields such as land and asset survey and valuation, statutory land acquisition and Land Title transfer in Uganda, disclosure of compensation schedules to PAPs, Compensation Agreement signing, Geodatabase management and relocation support for RAP implementation).
- Confirmation of staff resource to deliver the required services, with multiple teams working simultaneously along the pipeline route in Uganda.
- Proof of financial capacity to deliver the services required.
- Proof of current registration to the National Supplier Database for the year 2020-2021.
- Evidence of Company QHSE policy, procedure and process in compliance with applicable National and Industry standards for similar works.
- Proof of registration with the Uganda Revenue Authority and Tax Clearance Certificate for the latest year.
