

## REQUEST FOR EXPRESSION OF INTEREST: SPECIALIST ADVISORY SERVICES FOR EACOP

TotalEnergies East Africa Midstream B.V. (Company) Tanzania, an Oil and Gas company, invites experienced and reputable organizations to express their interest in providing Specialist Advisory services to the East African Crude Oil Pipeline (EACOP)

The EACOP project involves the construction and operation of a buried, cross-border pipeline to transport crude oil from the Lake Albert area in Uganda to the eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale in Hoima District, Uganda, to Chongoleani, Tanga Region, in Tanzania. The length of the pipeline is 1,443 km, of which 1,147 km will be in Tanzania traversing eight (8) regions.
