- · Proven track record of experience in providing similar services to the Oil and Gas market in the last five (5) years.
- The Supplier MUST be a certified service partner by the vendors in the marketplace
- · Relevant ISO & Industry Certification (ISO 27001 mandatory)
- · A commitment to and evidence that they have experience in developing national content value
- · Quality assurance & Quality Control plan/procedures in place for the execution of similar type of work.
