Package-1: Provision of Provision of cleaning service, cooking service, laundry related services, and housekeeping services to EACOP owners at temporary camps in compliance with Western catering standards.

The services include but not limit to, the following:

- a. Provision of laundry and cleaning services.
- b. Provision of cooking services.
- c. Provision of housekeeping services.

Minimum Requirements:

- a. Proof of business registration and business license for Tanzania
- b. Registration with the Tanzania Tax Revenue Authority
- c. Proof of Tanzania Tax Clearance Certificate for the latest year available
- d. Good Financial capacity to deliver the services as required.

- e. Compliance with petroleum (local content) regulations, 2017 and local company definition for Tanzania.
- f. Service standards meet the requirements of HACCP standards, in addition to having the certification of enterprises preferred.
- g. Have the resources and ability to provide services in the TANGA area.
- h. Experience in field camp services and management for engineering projects.
- i. Proof of registration/application to local supplier service provider (LSSP) database at the time of EOI submission is strongly recommended

Package-2: Provide pest control services for temporary camps in the field of engineering projects.

The services include but not limit to, the following:

- a. Provide fumigation and other environmentally friendly forms of pest control methods that meet the requirements of environmental protection (the main pests to be removed are termites, rats, vipers, mosquitoes, etc.)
- b. Provision of other related pest control services.

Minimum Requirements:

- a. Proof of business registration and business license for Tanzania
- b. Registration with the Tanzania Tax Revenue Authority
- c. Proof of Tanzania Tax Clearance Certificate for the latest year available.
- d. Good Financial capacity to deliver the services as required.
- e. Compliance with petroleum (local content) regulations, 2017 and local company definition for Tanzania.
- f. Experience in the control of pests in temporary camps in the field. g. Proof of registration/application to local supplier service provider (LSSP) database at the time of EOI submission is strongly recommended.
