E.A.L.S Limited Tanzania as the Main Logistics Contractor for the EACOP Project, invites experienced and reputable organisations to express their interest in supply of office furniture to the East African Crude Oil Pipeline (EACOP) project.

The EACOP project involves the construction and operation of a buried, cross-border pipeline to transport crude oil from the Lake Albert area in Uganda to the eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale in Hoima District, Uganda, to Chongoleani, Tanga Region in Tanzania. The length of the pipeline is 1,443 km, of which 1,147 km will be in Tanzania.

BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES REQUIRED

Supply, delivery, and assembly of standard desks, document hold cabinets, office chairs, pigeonhole cabinets.

MINIMUM REQUIREMENTS: Companies expressing their interest are invited to document their request with:

- Proof of registration with the Tanzania Revenue Authority and Tax (TRA) Clearance Certificate for the latest year available
- Proof of registration/application to Local Supplier Service Provider (LSSP) database at the time of submission of the response to this expression of interest is strongly recommended (RECOMMENDED)
- Compliance with Petroleum (Local Content) Regulations, 2017 and Local Company definition for Tanzania
- Latest Filed Annual Returns together with the payment receipt
- Copies of government issued IDs for all shareholders
- Company policies and procedures i.e. HSE, AML, Human Rights etc
- Certificate of incorporation/ Registration from the registrar of companies (BRELA)
- TIN Certificate, all valid business license and permits
- Recent audited financial statements
